REACH Declaration of Conformity

Declaration on Regulation EC No. 1907/2006 on the Registration, Evaluation, Authorisation, Adaptation, Exceptions, Regulations and Restriction of Chemicals (REACH).

As a manufacturer and distributor of fasteners, milling and turning parts made of special materials, TS Verbindungsteile GmbH is only affected as a downstream user. Obligations due to the manufacture and marketing of substances and chemicals for pre-registration or registration for our products not applicable.

Our delivered products are articles and therefore not to be defined as a substance or preparation (according to Article 3 definitions of REACH VO). Substances are not released from our products.

According to Art. 7, these only have to be registered if they contain chemicals that are intended to be released. This is not the case with our fasteners. They also do not contain any substances in a concentration of more than 0.1% by weight per article that are named in the current candidate list REACH VO (Article 57, Article 59 paragraph 1 of July 2016).

As a downstream user, we will meet all the requirements and information placed on us by the REACH regulation. The above statement is based on the information currently available. This statement is not legally binding for us. We make this statement in good faith, but we make no representations as to its completeness or accuracy and accept no liability for any damages resulting from reliance on any such statements.

If necessary, we will inform you about relevant changes caused by REACH with regard to your products, their ability to deliver and the quality of the parts we deliver to you within the scope of our business relationship and coordinate suitable measures with you in individual cases.

RoHS Compliance Statement

The new directive 2011/65/EU (called RoHS II) restricts the further use of lead (PB), cadmium (Cd), mercury (Hg), hexavalent chromium (Cr-6), polybrominated biphenyls (PBB) and polybrominated diphenyl ether (PBDE) in certain electrical and electronic equipment (EEE).

TS Verbindungsteile GmbH confirms that the delivered products (Products) comply with the specifications of the EU Directive 2011/65/EU (RoHS II). The materials or chemicals used do not contain any of the pollutants mentioned, or they are only contained as an alloy content within the permitted limit values in the raw material, taking into account the exceptions according to Annex III of the directive.

These are the following RoHS-relevant substances and substances:

- Lead (Pb) max. 0.10%
- Polybrominated biphenyls (PBB) max. 0.10%
- Cadmium (Cd) max. 0.01%
- Polybrominated diphenyl ethers (PBDE) max. 0.10%
- Dibutyl phthalate (DBP) max. 0.10%
- Diisobutyl phthalate (DIBP) max. 0.10%
- Di (2-ethylhexyl)phthalate (DEHP) max. 0.10%
- Butylbenzylphthalate (BBP) max. 0.10%
- Hexavalent chromium (Cr-6) max. 0.10%
- Mercury (Hg) max. 0.10%
